- After reviewing the bids submitted, a motion was made, seconded and approved to accept the bid from Nelson Seal coating to sealcoat Lough Drive, Broadwood Ct and Pine Glen Cir at a cost of \$22,537.83,

- good weather permitting, this fall after the curbs have been installed. This price includes some asphalt patching and crack filling.
- After reviewing the bids submitted, a motion was made, seconded and approved to accept the bid from Kingsbury Concrete to replace portions of porches, landing and walks which have cracks and separation which are tripping hazards at the units at 10405. 10407 and 10411 Pine Glen Cir at a total cost of \$10,638 which includes a 10% discount.
- Proposed contract for deck painting will be presented to the board by e-mail for vote so painting can be done in good weather.
