- After reviewing the bids submitted, a motion was made, seconded and approved to accept the bid from Steele Blades to add dirt, seed & straw behind new curbing and water same at a cost of approximately \$1800.

- A motion was made, seconded and approved that Robert Price will be allowed to continue working on property, by himself only, if he signs an independent contractor liability form and hold Woods of Glenmary Patio Homes harmless. Ben Adams wishes to go on record as being opposed to this proposal.
- Painting of Decks on Lough Dr will begin soon.
- A motion was made, seconded and approved to accept the plant replacement list plus additions.
- Foundation settlement ar 10425 Pine Glen Cir was examined and found not to be serious enough to merit attention at this time.
- The sunshade at 10413 Pine Glen Circle was approved if it is put up when not in use.
