- 5. 8714 Broadwood Court Homeowner has a gap in the door between the garage and the house. Homeowner had called Ben about it. The gap was in the pedestrian door leading from the garage into the house. Ben gave her the name of a handyman that could install some weather-stripping. The homeowner was going to call him.

- 6. 8733 Broadwood Court Homeowner sent in a request to Ben that the Bradford Pear, that had lost a limb in the ice storm be removed. Ben told him he would send Greenscapes out. He also told him that the tree would be replaced with an ornamental (dogwood, redbud or a Japanese maple) sapling. The tree was removed; however, Mr. Dotson was not happy with the replacement options or size. He wanted the HOA to replace with a comparable sized pin oak or king maple. I told him that our policy was to replace any removed tree with a sapling, plus both the oak and maple would grow too big for the area. Mr. Dotson was supposed to get back to Ben with his decision on the replacement. Update Mr. Dotson is working with Greenscapes to find a suitable replacement tree that complies with our policy.
  - 10211 Pine Glen Circle One or two pieces of siding between the garages have been pulled away from the house. Work to put the siding back in place is complete.

## VI. Committee Reports:

- A. Landscaping:
  - 1. A&L Forms
    - a. Nothing submitted in August.
  - 2. Flagpole decision The board discussed displaying the American flag by homeowners. The board adopted the policy that a stand-alone flagpole in the yard would not be approved by the HOA. However, if the proper A&L form is submitted, the board will approve placing a bracket on the front facia of the brick veneer at the front of the unit so an American flag can be flown. This would be done at the homeowner's expense.
  - 3. Chimney repair Ben received a quote on repair work for the brick chimneys in Sections 1,2,3 and 4. Plans are to do the work in 2020 and include the cost in the 2020 budget.
  - 4. All damage, including mailbox damage, incurred during paving should be finished the week of 9/23
  - 5. Painting of all front door trim and base of columns that needed it has been completed. Windows were caulked; however, Ben has asked the contractor to go back and recheck to ensure nothing was missed.
  - 6. Tree trimming/landscape replacement Ben has asked Greenscapes to provide an estimate. In addition, he will ask Greenscapes to check the pine trees in the park area that are leaning. The board has requested that the Landscape Committee develop a communication to the neighborhood about bushes and shrubs. Because of the drought this

year, we are expecting to lose a lot of bushes and shrubs and replacing them will have a significant impact on the 2020 budget.
