### VI. Committee Reports:

- A. Landscaping:
  - 1. A&L Forms None
  - 2. Tree trimming estimate is \$2915. Decision on trimming The Board approved the trimming for 2019.
  - Estimate for replacing plants due to the summer drought is ~\$23,000.
    Further discussion on plant replacement was tabled until the December 2019 meeting.

- 4. House settlement issues Possible settlement issues at 10251 and 10425 Pine Glen Circle. We are waiting on a structural engineer to asses and determine next steps.

A. MSD update – We received a letter from the attorney requesting the Board to sign a letter of intent to pay before he would file the lawsuit. We thought this had already been done, but evidently there was some miscommunication at the lawyer's office and a document had never been signed. The Board took this as an opportunity to have one last discussion about the lawsuit and determine what we believed would be the best next steps.

A motion was made and approved to terminate litigation with MSD – We believe this is in the best interests of the neighborhood.

A second motion was made and approved to investigate hiring a hydrologist to assess current drainage areas and basins in hopes of getting a reduction of the MSD drainage fees.
