Board Meeting Minutes February 17, 2023

1. Call to Order: Paul Stewart called the meeting to order at the Republic Bank at 9:07am.

2. Attendance:

3. Reading and Disposal of Minutes: Motion was made, seconded, and approved to accept the December Board Meeting Minutes as written. They will be posted on the WOG website.

4. Current Financial Report:

- a. Reserve transfer of \$14,025.42 was made in January.
- b. Two properties are currently in foreclosure and working their way the legal process.
- c. Delinquent accounts are few and manageable.
- d. Early termination of our Chase CDs and reinvesting in new CD's at higher rate was considered and rejected.
- e. Given the age of the CDs, early withdrawal penalties would offset the gains we'd realize resulting in no material advantage.
- f. Our Treasurer's been authorized to buy a \$50K CD with funds from our operating account to take advantage of current interest rates.

5. Reports of Officers and Committees:

- a. Landscape/Building:
 - i. No new A&L forms.
 - ii. Re: cracks and possible settling at 10425 PGC. Our property manager is waiting for the homeowner to provide information on previous repairs.
 - iii. A survey of the WOG homes and a quote for repointing damaged mortar and repairing damaged brickwork should be available by March 1.

- b. Gutters and Downspouts Project:
 - i. Replacement will begin ASAP in Sections 1 and 2.
 - ii. The Board reserves the option of replacing gutters and downspouts in Sections 3 and 4 later this year.
 - iii. Replacement in Sections 3 and 4 depends on the Board's evaluation of the HOA's financial position after determining the costs for upcoming masonry repairs and shrub replacements.
- **6. Social:** Fifteen people attended the Monthly Breakfast at Cracker Barrel. Next Breakfast is on March 21.

7. Old Business:

- a. MSD Dispute
 - Roger Setters tried to reestablish with his contacts at MSD.
 - ii. They didn't respond.
 - iii. The Board will consult with the HOA's attorney on March 17 to develop an HOA-driven plan to end this dispute.
 - iv. Paul will prepare a document summarizing the current situation and pertinent events of the last six years and submit to the Board by March 3.
