- 4. Asphalt Crack Filling Work is complete.
- 5. The patio replacement at 8801 Jessica Way is in progress.
- 6. Gutter/Downspout Project
 - The gutter project is still on hold until late 2023 or early 2024 due to the higher priority projects. Once other projects are complete, the board will determine when to restart this project.
